NOTIFICATION

No.F.1/16/07/HG/ - In exercise of the powers conferred by section 8 of the Bombay Home Guards Act, 1947, as extended to the National Capital Territory of Delhi, the Lt. Governor of the National Capital Territory of Delhi, hereby, makes the following rules to further amend the Delhi Home Guards Rules, 1959, namely: -

1. Short title and commencement - (1) These rules may be called the Delhi Home Guards (Amendment) Rules, 2008.
(2) They shall come into force on the date of their publication in the Delhi Gazette.
2. Amendment of rule 3. - In the Delhi Home Guards Rules, 1959 (hereinafter referred to as 'the Principal Rules'); in rule 3 -
 - (i) in clause (b), for the figures and words "60 years", the words "fifty years" shall be substituted;
 - (ii) in clause (c), for the words "fourth primary", the words "class tenth" shall be substituted.
3. Amendment of rule 8. - In the principal rules, in rule 8, after the proviso, the following proviso shall be added, namely: -

"provided further that the tenure of three years shall be extended for another term of two years subject to discipline, satisfactory service records, general conduct as Home Guards during the tenure of last three years and also subject to physical fitness".
4. Amendment of rule 9. - In the principal rules, in rule 9, for the words "sixty years", the words "fifty years" shall be substituted.
