Regarding: Providing RTI online ID's and Passwords

Sir/Madam,

In order to streamline the existing setup, the Competent Authority has nominated additional PIO's for timely disposal of the RTI applications in the various Branches/Homes/Institutions/Services of the Department. The RTI Cell is forwarding/transferring the applications to the concerned branches and also to other Public Authorities, under the intimation to the applicant. The concerned Departmental PIO's are disposing off/furnishing the Status Reports of these RTI applications. It is observed that in a large number of cases, the applicants are filing Appeals on the information provided by the PIO's on account of delay and less number of Public Information Officers.

The Branches/Homes/Institutions/Services are allotted the RTI -online IDs and their passwords, so that they can dispose off the same at their level within the prescribed time limit under the RTI Act, 2005.
